They do not restrict solicited marketing. Put simply, a solicited message is one that is actively requested. So if someone specifically asks you to send them some information, you can do so without worrying about PECR (although you must still say who you are, display your number when making calls, and provide a contact address).

An organisation might be able to use your data for legitimate business interests. Legitimate interests is likely to be used in situations where the organisation is using your personal data in ways you would reasonably expect and which are low-risk and won't have a big impact on you, or if the organisation has a compelling reason for the impact.
